

### **Requirements for Ukraine Residence by Investment**

The Applicant must possess a valid passport or another foreign travel document and must have a clean criminal record.

Close family members of the investor are eligible to acquire permanent residence and obtain Ukrainian citizenship in several ways. The main applicant's spouse and unmarried children under 18 are eligible to become permanent residents after the main applicant is granted resident status. A main applicant's spouse is only eligible if the spouses have been married for no less than 3 years at the time of application. Spouses and children of the applicant are eligible to acquire permanent residence. Though, they will not be granted citizenship at the same time as the applicant.

The applicant must apply for a permanent residence permit and ID card in Ukraine. Applicants are not required to be in Ukraine during the whole process. However, when applying for a permanent residence permit and ID card the investor is required to be present in Ukraine. There are a number of documents that have to be prepared and legalized including, but not limited to, a criminal record certificate, marriage license, proof of funds, etc.

#### Procedure for Ukraine Residence by Investment

- Submission of initial documents and signing of the investment agreement.
- Transfer of application fee.
- 1st trip to the Ukrainian consulate for signing the relevant documents and POAs.
- The agent registers a company and opens a bank account in the name of the investor.
- The investor transfers the investment of USD 100,000 in his/her bank account.
- 2nd trip to the Ukrainian consulate to apply for an entry visa.
- 3rd trip to Ukraine for submission of Application for Permanent residence.
- Approval of Permanent residence.
