### CITIZENSHIP BY INVESTMENT PROGRAM

Citizenship by investment in Vanuatu is available to applicants who invest from \$130,000 into a local development fund. Vanuatu, a chain of 80 islands in the south Pacific to the east of Australia is part of the Commonwealth. The official languages are English and French.

Vanuatu has the only Citizenship by investment program in the Asia-Pacific Hemisphere. The programme offers one of the fastest citizenship and second passport programmes available for investors. The investment requirement is \$130,000 for a single applicant and \$180,000 for a family of four plus fees.

### Requirement for Vanuatu Citizenship by Investment

- Clean criminal record.
- Be over 18 but below 65 years of age.
- Have assets worth at least USD 250,000.
- Medical certificate.
- Make a contribution of \$130,000 for a single person or \$180,000 for a family of 4.

### Procedure for Vanuatu Citizenship by Investment

- Consult with a specialist firm about the program requirements, and prepare your required documents for submission.
- Submit your application, and wait while the Vanuatu government performs due diligence checks and goes through your application. If successful, you'll receive a pre-approved letter.
- Make the required investment and provide proof.
- Take the Oath Swearing Ceremony. Congratulations, you're now a citizen of Vanuatu!
