# **C II International Mobility Program**

# **Eligibility**

Eligibility for this program requires that the individual own at least 50% of the business. The applicant must also prove to the satisfaction of an officer that they will leave Canada should their immigration status not be extended.

**Processing Time** 9-12 Months

# **Key Benefits**

- C11 is an immigration route which allows you to purchase a business in Canada that is relevant to your work experience.
- There is no minimum investment however we need to show there is a legitimate business that is operational and you are able to run the business effectively,
- Additionally you will need show that you can support yourself financially when moving.
- Under the owner operator programme you can purchase 51% or 100% of the business depending on your goals and targets.

# PROVINCIAL ENTREPRENEUR PROGRAMS

Mid-range net worth individuals with suitable entrepreneurial experience may be eligible to apply under one of many Provincial Entrepreneur programs. The majority of these provincial business immigration programs require active participation in the management of a business based on a specified investment and job creation. The programs vary in the requirements to qualify but generally refer to a minimum net worth in the range of \$500,000 CAD to \$600,000 CAD, with relevant management experience.

Candidates interested in owning and actively operating a business are now invited to submit an Expression of Interest (EOI) using the new online EOI system. Only online submissions will be accepted.

# **Manitoba Entrepreneur Pathway Programme (MEPP Programme)**

The Manitoba Provincial Nominee Program (MPNP) has launched an interim process for applying to the Business Investor Stream Entrepreneur Pathway. This process will be in place until technical changes to the MPNP Online system are complete. The MPNP Business Investor stream requires updates to the MPNP Online application system. While the system is enhanced, a limited number of Entrepreneur Pathway candidates will be processed. The interim process uses the forms below. Once the system enhancements are complete, this interim procedure will end and all future candidates will use the online application system.

The Entrepreneur Stream is for experienced business owners or senior business managers who want to live in Nova Scotia. They must start a new business or buy an existing business and must actively participate in the day-to-day management of the business. After operating the business for a year, the entrepreneur may be nominated for permanent resident status. Application to the stream is by invitation only.

# **Ontario Entrepreneur Programme (OEP Programme)**

The Entrepreneur Stream is an immigration stream under the Ontario Immigrant Nominee Program (OINP). It is established under the Ontario Immigration Act, 2015 and its regulations. For your application to be approved you must follow the process and meet the criteria established under the regulations.

This stream is for entrepreneurs from outside Canada interested in starting a new business or buying an existing business in Ontario. It gives an entrepreneur (and up to one foreign national business partner) the opportunity to be nominated for permanent residence once their business has been established in Ontario.

# **New Brunswick Entrepreneurial Steam**

The New Brunswick Business Immigration stream is an economic immigration pathway for experienced entrepreneurs who are ready to establish, operate and actively manage a business while living and settling in New Brunswick permanently.

Applicants under this stream must meet the minimum eligibility requirements for age, language, education, personal net worth, business ownership and/or senior management experience, and business concept. Eligibility requirements must be met at the time of the EOI, application and nomination. Meeting eligibility requirements does not guarantee that you will be nominated.

# **Yukon Business Nominee (YBN Programme)**

The Yukon Business Nominee program targets entrepreneurs looking to establish a new business in Yukon, or purchase an existing business in the territory. Through the Yukon Business Nominee program, Yukon immigration authorities aims to "attract and retain skilled international entrepreneurs to add diversity and innovation to Yukon's economy." It is easy to imagine how a territory with approximately 40,000 residents may actively be searching for exciting new businesses to boost the economy, so if you have a solid business proposal and the resources to get started, the Yukon Business Nominee program could be your route to Canadian permanent resident status.

#### **Canada Startup Visa**

Canada's Start Up Visa Program, additionally usually alluded to as the SUV program of Canada, is a Canada migration pathway for qualified business people. Connecting creative business people with private area financial backers in Canada, the SUV program explicitly targets outsiders that have the capability of effectively building up their business in Canada. At first going to the country on a Canada work license – upheld by their assigned Canadian financial backer – such competitors will fit the bill for obtaining Canada PR once their business in Canada is completely functional.
