## **Partner/Spouse Visa**

Canadian spousal sponsorship is how a Canadian citizen or permanent resident can sponsor their partner to come to Canada and live permanently. In Canada, we know how important it is for families to be together. For this reason, applications for spousal sponsorship are considered a top priority.



## **Eligibility**

You will be eligible to sponsor your spouse or common-law partner if you are a **Canadian citizen** or **permanent resident** and meet the following conditions:

- Are at least 18 years old
- Live in Canada, or planning to return to Canada once your spouse or partner becomes a permanent resident of Canada
- Are able and willing to provide for the **basic financial needs** of your spouse or partner for **three years.**
- Must have a clear Police Record or must not be charged with any serious offence.
- Must have not been invited to Canada as a sponsored spouse within a span of the last 5 years.



If you are married and looking into sponsoring your husband or wife, immigration officers will expect to see the following evidence:

- Relationship Information and Sponsorship Evaluation questionnaire
- Marriage certificate (see common-law if you are not married)
- Wedding invitations and photos
- Birth certificates or adoption records for any children you and your spouse have together
- Proof of registration of marriage with a government authority

And at least two of the following documents:

- Proof that you and your spouse own property together
- Shared bank accounts,
- Utility bills with both of your names,
- Copies of government-issued IDs,
- Car insurance,

Pay stubs or tax forms that show that you live at the same address

## **Super Visa**

The Parent and Grandparent Super Visa for Canada allows parents and grandparents of Canadian citizens and permanent residents to visit Canada for extended periods. Parents and Grandparents citizens can live in Canada for two years without the need to renew their status

- Invitation letter from host.
- Parents or Grandparents must provide financial support from their child (host) and meet minimum & household income. (around minimum \$17,000)
- Prove Canadian medical coverage insurance (for at least 1 year) and be valid for each entry to Canada.
- Must pass medical examination.
- Minimum necessary income of host will be \$33,000.

- Date of Birth/Country of Birth.
- Parent/grandparent Address and Phone Number
- Relationship to the host (citizen or permanent resident of Canada)
- The purpose of the trip.
