Requirements of Ireland Residence by investment

1. €1,000,000 Enterprise Investment

Invest in either a single Irish enterprise or spread over a number of enterprises. The enterprise can be a start-up or existing business but must be registered and headquartered in Ireland and the investment must support the creation or maintenance of employment.

Minimum investment period of 3 years.

2. €1,000,000 Investment Fund

Invest into one of the funds that have been approved for the purposes of the Immigrant Investor Program by the Irish Naturalisation and Immigration Service and are regulated by the Central Bank of Ireland.

All funds must be invested in Ireland.

Minimum investment period of 3 years.

3. €2,000,000 Real Estate Investment Trust (REIT)

Invest in any Irish REIT that is listed on the Irish Stock Exchange. The investment may be spread across a number of different Irish REITs.

The full investment must be held for 3 years.

After 3 years 50% of shares can be sold.

After 4 years a further 25% can be released.

After 5 years there are no requirements to keep investments.

4. €500,000 Endowment

Invest in a public project benefiting the arts, sports, health, culture or education. It should be regarded as a non-refundable philanthropic contribution and investors will receive no financial return.

Procedures and time frame of Ireland residence-by-investment

Application: First, you make an application, without committing to any investment funds. Investors favor this feature as they don't need to deploy the funds and make the investment before they get approval for the residency permit.

Due Diligence: The Evaluation Committee checks and approves your application. Please note that all applications are subject to a due diligence process in respect of anti-money laundering, Know Your Client, Politically Exposed Persons, and sanction checks. Additionally, the officials are engaging in data sharing by the OECD common reporting standards.

Investment: You proceed with an investment in accordance with your approved application.

Proof of investment: Finally, you prove that you have made the investment.
